COURSE DESCRIPTION AND OBJECTIVES

Welcome to CRJS480, Senior Seminar! CRJS 480 is the Criminal Justice Program's capstone course designed to assist students to apply and to think critically about current knowledge regarding crime, crime trends, law, law enforcement, the adjudication process, corrections and crime prevention. Together, we will explore and engage in scenarios, research, and evaluation of different viewpoints concerning campus crime to develop competencies to advance effective argumentation and appreciate the diversity of thought and inquiry in justice studies.

Under that backdrop, campus crime is an important issue to understand and address given that members of the university community—students, faculty, and staff—should feel safe on campus, should feel comfortable in expressing diverse viewpoints, and should feel protected when crime threats emerge.

The goals of this course are two-fold: (1) to introduce students to research about crimes that occur on college campuses, and (2) to increase understanding of the policies that have been implemented to reduce misconduct and campus violence. By the end of this course, students will be able to *demonstrate an understanding of*:

- the nature, extent, and reporting of campus/university crime;
- policies and practices designed to reduce campus violence;
- "what works" in crime prevention on the college campus;
- the importance of social activism and the exchange of ideas on the college campus

Moreover, upon completion of this course, students will master specific skills:

- how to identify empirical research relevant to a topic of interest;
- how to summarize large bodies of knowledge;
- how to synthesize a variety of studies;
- how to undertake and complete a literature review on a specific topic related to campus crime;
- how to conduct interviews of practitioners and professionals in the field;
- how to communicate findings from their research evaluation

After successfully completing this course, students should be able to appreciate the growing body of research that has been devoted to this topic. Moreover, given the focus on writing, communication, and application, students should be better prepared to debate and discuss the logic behind campus-based initiatives to reduce campus violence.

This course is designated as RON-L (100% asynchronous delivered) course, meaning we will NOT meet at scheduled times or in-person. Rather, there will be a series of assignments, assessments, and modules that students will complete on their own time. Dr. Mancini recognizes this can be a challenging delivery. For this reason, she has designed the course with several "touch points" in mind and provides a range of dates to complete assignments and review modules. Even so, students should ensure they are ready for this style of delivery. All course units and due dates for assignments and assessments can be found under the "Course Overview and Schedule" of this Syllabus. Note that while we do not meet in person, this Course Overview and Schedule does rely on the "Tuesday"/"Thursday" schedule. However, students should rest assured that they will have time to work on each assessment (i.e., a range of time is given in which an assignment or activity "opens" and when it closes/is due).

When in doubt, please ask! Dr. Mancini and Nick are more than happy to chat with you and make sure you are on the right path.

COURSE REQUIREMENTS AND POLICIES

Content Exams (52.8 percent of grade). There will be three required exams given during the semester. Students are expected to read assigned material prior to the due date in the course calendar. Some chapters/readings will be covered fully in class, while others may not. *However, the instructor reserves the right to include all readings and lecture material on exams*. Each exam will consist primarily of multiple choice, fill-in-the-blank, true-false (objective), as well as <u>short answer</u> and <u>essay</u> questions covering the course material (i.e., lectures, discussions, and readings). Failure to complete the exam by the due date (see Course Calendar and Overview). For unexcused absences, Dr. Mancini will allow a make-up the with a late point penalty (-20 points and exam may be in a different format). For absences because of a university-approved reason (see "Makeup Policy" sub-

section below), a makeup (with no penalty) will be permitted. In either case, students must notify Dr. Mancini and the GTA as soon as possible.

Term Paper (24.2 percent of grade). Over the course of the semester, students will work independently in preparing an APA formatted 6-8 page paper (title page and references not included in total page length), double-spaced, Times New Roman (12 point font) that critically examines an issue related to campus crime and safety, the theme of our course. *Your topics are restricted to the following: 1) alcohol/drug use/misuse, 2) sexual misconduct/assault/Title IX, 3) hazing, and 4) school shootings.* The paper must be submitted online via a plagiarism detector (Canvas submission) by 12/3. In taking this course, the student acknowledges and accepts that their paper will be submitted to a plagiarism detector (e.g., TURNITIN, SAFEASSIGN). Plagiarism is a very serious academic offense. Refer to the University's academic dishonesty policy which outlines the severe sanctions associated with plagiarism. Dr. Mancini is happy to clarify the University's plagiarism policy and the process for plagiarism detection. Please also see the resources below to ensure you avoid plagiarism:

The library has excellent resources to help you write with integrity. Additionally, consider contacting the Writing Center (<u>http://uc.vcu.edu/learning-support/writing-center/</u>).

Students must have prior topic approval early in the semester (topic should be submitted via Canvas-Assignments-Paper Topic by 8/30, 11:59 pm). They should submit a proposal of their paper no later than 9/6, 11:59 pm. The proposal should include all of the required headings (see p. 2 of the rubric) and a brief overview of what each section will cover. Students should also provide THREE APA references (i.e., examples of the scholarly research, such as peer-reviewed articles) that will be incorporated in the paper). Finally, the proposal should include a listing of THREE databases (e.g., ProQuest, see also, <u>https://apps.library.vcu.edu/dblist/category/133</u>) that students will use to identify scholarly work for their citations. Paper resources are posted on Canvas (under "Modules," "Term Paper").

The final draft of the term paper is due by 12/3, 11:59 pm. Not meeting these deadlines will delay our feedback. While students do not receive a grade for the proposal, not submitting one will likely adversely impact the score of the finalized draft. The amount of credit will depend on the thoroughness and rigor of the paper, as well as the organization of the main ideas. In addition, the paper will be graded on spelling, grammar, and formatting. In order to receive full credit, students are encouraged to follow the rubric guide posted on Canvas (under "Modules," "Term Paper"). Students should feel free to contact Nick or Dr. Mancini for any clarification or assistance in starting their paper. They are also happy to review preliminary drafts with at least 48 hours' notice (excluding weekends and holidays). Late papers will be docked one letter grade for each business day not received.

Group Projects (3 percent of grade). During the semester, the instructor will assign a series of group exercises. Groups are randomly assigned. Early on, group members should communicate about what type of schedule works best for them. There needs to be some type of interaction (e.g. Zoom discussion, discussion board chat, etc.) that will be submitted along with the completed assignment. Each student is graded individually so all work/documentation should be submitted for each group member. Within the group setting, students will tackle a specific prompt/exercise designed to replicate a "real-world" dilemma in the field (see "Course Overview and Schedule" for due dates). ALL group members must make meaningful contributions. Students who do not do so will face a loss of points. Dr. Mancini and Nick expect that students will interact with each other in a respectful and effective manner. Any deviation from this should be reported ASAP to both Dr. Mancini and Nick.

Students who miss the deadlines for any of these assignments for legitimate reasons (e.g., illness that requires a doctor's visit, being involved in a car accident) and present documentation to the instructor within ONE week of "returning" to the University will be allowed to complete an alternate assignment (which may include a 2-3 page paper). <u>Work-related responsibilities (with the exception of military, federal, or state service), weddings, parties, vacations, or other social activities not described in the University Attendance Policy are NOT considered legitimate excuses, and in these cases, students will receive a grade of "zero" for any missed quizzes or group assignments.</u>

Since students will be required to complete several online assignments, it is imperative that they ensure their work has been properly submitted to Canvas. In rare cases of technical problems, students should immediately email Dr. Mancini (within five minutes of experiencing the problem) and thoroughly explain the issue they have experienced. They must also contact VCU's helpIT Center (http://www.ts.vcu.edu/helpit-center/). In consultation with VCU's IT staff, Dr. Mancini will decide whether the problem was severe enough to prevent the student from completing the assignment on time. In instances where evidence exists that this is the case, she will allow a re-take of a quiz, or a makeup of any assignment. MULTIPLE ALLEGATIONS OF EXPERIENCING TECHNICAL PROBLEMS WILL NOT BE CONSIDERED. IN THESE CASES, STUDENTS SHOULD COMPLETE THEIR WORK AT A VCU COMPUTER LAB.

Reflection Assignments (2 percent of grade). Toward the latter part of the semester—when the course explores "special topics" concerning campus crime—students will be responsible for completing a series of "reflections" which require review of a media source or documentary. Students should then record their reactions to the content (see Canvas, "Assignments" tab for further information). Due dates for these assessments can be found on the Canvas Assignments tab or the "Course Calendar and Overview" section of this document. The same late policy articulated in the "Group Projects" section applies here.

APA Quiz (8 percent of grade). Students will be required to complete an APA quiz that will assess their mastery of APA formatting which is a key objective of this course. The quiz will open on 9/28 and close on 10/3. Students should consult the APA resources on Canvas and their textbook (Writing in Criminal Justice) to prepare for the quiz. In addition, an APA "bootcamp" will be provided prior to the opening of the quiz.

Term Paper Presentation (1 percent of grade) and Review of Colleague's Presentation (1 percent of grade; total=2 percent of grade for this section). At the end of the semester, students will present the findings of their term paper. Students must prepare a voiced powerpoint or video (15-20 minutes) for other students to consult on Canvas (see "Term Paper Presentation" tab). It is due by the end of day on 12/3, 11:59 pm. In addition to this assessment, students must choose at least one other colleague's presentation and comment on a) its content, b) its delivery/style, and c) overall thoughts of the quality of the information conveyed. A template of this review form can be found on Canvas ("Term Paper Presentation" tab). The review form is due on 12/5, 11:59 pm. Both the presentation and review form should be submitted on Canvas ("Term Paper Presentation" tab).

Practitioner Interviews (3 percent of grade). Early in the semester (8/30, 11:59 pm) students will submit their topic of interest (the focus of their paper-thus, the "topic" for the practitioner interview must be the same as the term paper topic). Students will be selected to work in groups based on their common interest (e.g., Title IX, hazing, active shooting policies, substance abuse awareness, dating violence). TO BE CLEAR, THE TERM PAPER IS AN INDEPENDENT ASSESSMENT (I.E., IT IS NOT A GROUP PROJECT). HOWEVER, TO ENSURE ADEQUATE ENGAGEMENT, THE PRACTITIONER INTERVIEW IS COLLABORATIVE AND STUDENTS WILL NEED TO WORK IN GROUPS TO FULFILL THE PARAMETERS OF THE ASSIGNMENT. Groups are assigned based on mutual interest (which is why we ask you to submit your paper topic by the due date mentioned earlier). Dr. Mancini will announce the groups as quickly as possible so that students can contact one another to form a plan. Specifically, students will need to identify a local agency (e.g., VCU police department, Student Government Association, non-profit) that addresses their topic of interest. From there, they will then consult the "Practitioner Interviews" document on Canvas (Practitioner Interviews tab, under "Modules") which lists specific instructions and possible questions to be asked of their participants. The interview should last around 20-30 minutes (no longer so as to respect the practitioner's time) and students should follow the VCU Honor Code at all times in their interactions with practitioners (https://conduct.students.vcu.edu//vcu-honor-system/academicmisconduct-/honor-pledge/). Together, students will determine a) who they will contact, b) the method in which the interview will talk place (Zoom, in-person, phone?), and c) coordinate to undertake the interview. All students are required to participate in the interview. In addition to responses to the questions (which you will both record in a method of your choosing—be sure to let the participant know you are recording), you must submit a one-page typed reaction paper to the experience (e.g., describe the participant, the setting, were you surprised by responses, did you feel comfortable undertaking this method?) This reaction paper as well as the interview transcript should be in APA format. In addition, you must discuss the findings from your practitioner interview in your term paper.

Please be professional in your interactions with practitioners. We will discuss interviewing and qualitative research on 9/24. We will also be reviewing your interview plan which is due by 10/16, 11:59 pm. Not submitting your interview plan on time could result in a zero for this assignment (submit your interview plan no later than this date via Canvas, Assignments, "Practitioner Interview"). Late submissions will be docked by ten points for each day not received (thus, the highest score you can receive if you submit the plan late is 90%, with 10 additional points taken off for each day not received). Please check in with us with any concerns. The final interview write-up is due on 11/12, 11:59 pm. It should be submitted to Canvas. Late submissions of the finalized interview write-up will come with a substantial late fee penalty (10 points take off for each day not received). Your interview must be incorporated in the Term Paper (see "Term Paper Resources" on Canvas, under "Modules").

Criminal Justice Program Assessment Assignments (5 percent of grade). Senior Seminar is our "capstone" course in the Criminal Justice Program, meaning it is designed to synthesize <u>all that you</u> <u>have learned</u> thus far in our curriculum! The Criminal Justice Program Faculty are committed to both the integrity of our curriculum and to our students' success. To better understand both, we regularly evaluate student learning outcomes, and we complete an annual assessment of our graduating seniors. Toward the end of this course, you will complete an online assessment of core criminal justice concepts you have learned during your time in our program.

What is the criminal justice assessment? The assessment is an objective, multiple choice series of questions related to both CRJS 254 Introduction to Policing and CRJS 253, Introduction to Corrections. To help you jog your memory on the content mastered in these courses, the Program provides a list of "key terms" and "concepts" to help you along in reviewing the material you should know for the assessment. You can find these resources on Canvas, under "Assignments," "CRJS Assessment." <u>Completing the practice quiz AND actual Program assessment is REQUIRED</u>. Both portions are worth 2.5 percent of the overall grade (thus comprising 5 percent of the overall course grade). Please take these assignments seriously and feel free to share any concerns with Dr. Mancini. <u>You MUST complete both the practice quiz and assessment no later than December 5, 2024</u> (11:59 pm). Please see Canvas (Assignments) for full details.

Makeup Policy (Exams). The course has a very strict exam makeup policy. You should make necessary arrangements to complete exams by the specified due dates. If you fail to take an exam for any reason, you will receive a default grade of "zero" unless the exam was missed due to a University approved excused absence. The following sub-sections clarify the course policy regarding makeup exams for a) non-excused absences, and b) excused absences with written documentation.

Non-excused absence policy. In cases of non-excused absences, Dr. Mancini will permit a makeup (with an automatic <u>20-point deduction</u>) without documentation for ONE missed exam only. Thus, for this one-time exception, students may makeup an exam BUT can only receive a maximum score of 80 percent (less, of course, missed questions). Students are responsible for contacting the Instructor or Graduate Teaching Assistant (GTA) to schedule make-ups for non-excused absences. They must be scheduled within one two business days of missing the exam. Failure to complete the makeup exam by the due date or to contact the Instructor/GTA within the specified time frame will result in a "zero" score. To ensure academic integrity, the Instructor reserves the right to provide makeup exams that are substantially different from those given to other students (e.g., essay exams). Under no circumstances does this policy apply to "retakes." That is, students may not retake exams to improve their overall course average.

Excused absence policy. The University has outlined examples of permitted excused absences (http://bulletin.vcu.edu/academic-regs/university/attendance/). In these cases, where a written prior notice and documentation are provided, <u>students</u> must assume responsibility for scheduling a make-up exam. Failure to schedule a make-up or complete the exam by the scheduled time of the make-up will result in a "zero." The make-up exam may involve a different format (e.g., short-answer and/or essay). The documentation must be received within two business days of missing class.

Makeup Policy (Other Assessments). Other missed assignments/assessments can only be made up with proper documentation noting the specific reason for the missed work. Missed assignments due to non-University approved events cannot be made up. The University's attendance policy can be

To receive credit, students MUST sign up for an appointment with Office of Student Services for a meeting to assist them in developing this document (https://wilder.vcu.edu/students/student-success/) OR use through VCU Career Services (https://careers.vcu.edu/). If pursuing this option, students MUST let Nick and Dr. Mancini know of their intention no later than *December 5, 11:59 pm*. The finalized CV and documentation of your meeting must be submitted to Canvas by 12/10, 11:59 pm. Please note that OSS and VCU Career Services require appointments and may have limited availability. Thus, please make your appointment well in advance of any deadlines.

Other Extra Credit Opportunities. Any other form of extra credit will be awarded solely at the discretion of the Instructor and will be open to all students. Dr. Mancini will either announce the opportunity in class (e.g., 0.25 points added to final overall score for attending a guest lecture) or post an electronic notification via Canvas and/or email. Dr. Mancini does not respond to requests regarding individualized extra credit opportunities. There are no makeup opportunities for extra credit.

Core Course and Other Curriculum Policies. Depending on students' course of study, CRJS480 may be a required core course. Additionally, other policies may apply to the course. Students are encouraged to contact their advisors for guidance regarding these policies.

• <u>Our Classroom</u> This class is designed to maximize our collective learning and mastery of material while being flexible and cognizant of the current environment. This means, at times, students will need to review course content (e.g., lecture material) on their own. As a courtesy, Dr. Mancini has provided guides/lectures ("VoiceThread") to facilitate this form of independent learning. VoiceThread software requires that you are logged into Canvas. Depending on your computer system, there may be other requirements (see link: <u>https://ts.vcu.edu/askit/teaching-and-learning/voicethread---external-tool/</u>). These files are designed to be broad wrap-ups of big picture points mentioned in lecture. They are not designed to cover every point or example mentioned in class. Students are encouraged to contact the Instructor or GTA should they need clarification on specific points or course concepts. Should students have any difficulty in downloading the VoiceThread files, they should contact VCU's helpIT Center (http://www.ts.vcu.edu/helpit-center/).

• <u>Verbatim Course Description</u>. Semester course; 3 lecture hours. 3 credits. Prerequisites: CRJS 181, CRJS 355 and CRJS 380. Enrollment is restricted to seniors in criminal justice with at least 85 credit hours taken toward the degree. A capstone course designed to assist students to apply and to think critically about current knowledge regarding crime, crime trends, law, law enforcement, the adjudication process, corrections and crime prevention. Scenarios, research, projections and evaluation of different viewpoints will be employed to develop the student's ability to assess methods of argumentation, use information and apply existing knowledge to new fact situations.
